## Incorporation & Set-Up

1. Incorporation of private and public companies, branch offices, Companies Limited by Guarantee (CLBG), Limited Liability Partnerships (LLP), foundations, and societies registered under the Registrar of Societies (ROS)
2. Name search and retrieval of statutory information (name search is part of incorp)
3. Provision of registered office facility

## Governance & Ongoing Compliance

1. Maintenance of statutory records, directors, and shareholder/member registers
2. Preparation and filing of annual returns and all other statutory required documents
3. Share registrar support for unlisted companies, including managing share related exercises (e.g. dividend, share splits, bonus issues, rights issues, various classes of share allotments, share transfers, share redemptions, capital reductions, etc), dispatch of notices and reports, and meeting registrar duties
4. Support all corporate secretarial services, including preparation of resolutions and meeting minutes, as well as attendance at board/general meetings.
5. Communication with shareholders and regulators
6. Corporate governance advisory and compliance with Malaysian obligations (including foreign companies)

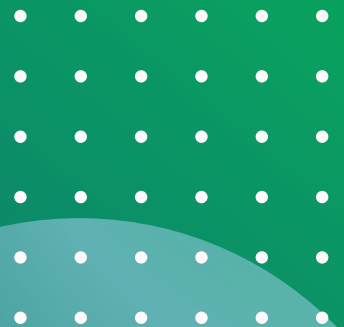
